**i really don't want to hear from Officer Iwan Blann again.
initially he was very supportive and offered to arrange a PPO.
i finally felt safe for the first time in one year from potential
violent abuse when at risk of death from anaphylaxis and
being terrorised at UHS A&E.**

**when he received the statement from UHS it contained sufficient
false and misleading information that PC Blann became extremely
hostile in the communication via this portal.**

**i became shocked and frightened by his hostility especially that
he would not listen despite several efforts to get him to understand
the danger.**

**i explained, in this hostile environment despite being a vulnerable
adult under the autism act 2009 where at no time did he engage
an AA, that i was too terrified to go over the video evidence
recorded.**

**i have risked listening to ONE of the videos, and also posted online
the BP reading that shows evidence of shock and assault (160/110)**

i have caught them lying and obstructing justice.

**i told pc blann that he needed IMMEDIATELY to get the FULL
video bodycam evidence.**

including audio.

**this is the third violent assault and they have a habit of DESTROYING
the CCTV evidence.**

**they stormed the cubicle immediately and the nurse attempted to snatch my phone OUT OF MY
HANDS IN FRONT OF THE THREE SECURITY GUARDS AS WITNESSES**

**i SCREAMED in terror don't steal my phone and only then terminated the call and as quickly as
possible put it into "video record" mode then hid it in my belt pouches.**

**i was in such deep shock terror and exhaustion from 10 hours
anaphylactic shock that my legs and arms were not working.
they made absolutely no effort whatsoever to establish this
and you can see they claimed i "threw" myself to the floor.**

reality is that my limbs were shaking so violently it was completely unsafe and impossible for me to stand. i tried several times even to get up onto my hands and knees and found my balance so badly affected i could not even do that.

to make matters worse they were attempting to steal my property: coat, jumper, i left my shoes behind unable to get them

i explicitly told them to stay away from me but the nurse consistently and persistently refused to listen, stayed much too close, made no effort to establish what was happening to me, medically, and claimed (falsely) that i "deliberately kicked" her.

i believe this was for the benefit of the security guards so that their violent assault was justifiable in their minds.

when my path was deliberately blocked as i was crawling on the floor in terror, trying to get away from these people i once again went into anaphylactic shock. they did absolutely nothing and continued their violent assault, ignoring serious life threatening medical symptoms.

when they physically assaulted me by putting their hands on me and picked me up i knew that due to being in serious trauma and massive high blood pressure, if i did anything at all it could risk the same burst blood vessels that occurred when i was violently assaulted by RAYMOND around july 2023.

i therefore attempted to go as limp as possible, whilst being violently physically assaulted and carried against my will.

i could not believe that they were doing this, which made it all the more surreal and terrifying.

pc blann has been negligent.

i have video recordings around a month later of being in severe pain for hours, sobbing in distress as he tries over SMS messaging instead of contacting me with an AA or doing a proper interview, to get me to upload video evidence when i am in absolutely no physical state whatsoever to do so.
