<p>The bundle is at act. 1-4663354668.</p> <p>The complainant has attended A&E, potentially on a number of occasions, at UHS in Hampshire which I assume refers to the University Hospital Southampton trust.</p> <p>The incident took place on the A&E Majors ward from 10-10:40 on 26 October 2024. We are informed that a female individual, who may or may not be a doctor has informed the complainant that they should leave A&E, which they have described as assault, citing case law for this due to psychological harm and the physiological effects. It appears the complainant was shook up by the incident, but it does not appear that the doctor touched the complainant and it is unclear if security personnel did so either.</p> <p>The complainant has reported this incident (and possibly others) to Hampshire Police and it has the crime reference number 44240466479.</p>

What information would the AR like to gain from pre-triage enquiries?

I think it is very unlikely that the police will choose to investigate this however as it has been reported, please can you get the police to confirm if they are investigating this matter. If they are not investigating this matter, please can they provide the rationale why not. If they are able to confirm the identity and profession of the individual who is subject to the concerns as being a doctor or not, it would be helpful for the decision. Any other information which the PTE owner would believe to be relevant for the decision also, thank you.
