i have extreme life thretening chronic athersclerosis from chonic peridontal disease, combined with hypoxia at birth that caused periventricular leukomalacia and subsequent asperger's autism.

i had no idea of this until i finally got an MRI scan july 2025 which showed strokes, ischemic damage, chronic athersclerosis and chronic periventrupicular white matter ischemia

i was repeatedly and systematically violently verbally abused by RAYMOND, but had no idea that i had chronic atheraclerosis.

each verblly abusive incident of which there were around 1,500 over a 16 year period almost all of them in earshot of my daughter

caused massive distress, cortidol release, blood pressure rises, brain inflammation, and more.

it got so bad that it was causing ruptured arteries including brain hemmorages and ischemic strokes, hypoxia, placing me at risk of death after collapsing at least 12 times.

i have a video recording that shows me pleading with RAYMOND to stop being abusive.

she systematically and repeatedly fails to do so.

that makes her violence WILFUL.

the effects are such that my face can be seen to swell up massively, indicating Anaphylaxis is underway from the bacterial toxic dump from damaged athersclerosis due to the cortisol and the blood pressure rise.

when i begin to get so distressed i am sobbing it causes such a high blood pressure rise it causes an ischemic stroke and i collapse on the floor, unaware medically at the of the seriousness of what has transpired.

i now know what happened, and have the medical evidence to unequivocably prove LONG TERM extreme serious medical disability.

that makes RAYMOND'S wilful actions 1861 Offenses Aginst the Person Section 18 "malicious GBH", and I, luke kenneth casson leighton, hereby ACCUSE RAYMOND OF THIS OFFENSE.

this is NOT A FALSE REPORT AND I AM A HUNDRED PERCENT AWARE OF THE LAW REGARDING FALSE REPORTS.

i have had to flee the UK to a commonwealth country due to persecution and chronic medical issues wilfully and malivioudly unisgnosed by the NHS.

i am entrirely depended for my life on the heir to the peerwge of 3rd Baron Hankey, Professor Alexander Maurice Hankey.

RAYMOND stole every penny i earned as she forced me to hand over my internet banking access, prohibited me from seeing banking transactions, and refusing for SIX YEARS to allow me control over my bank accout. i reported this to Nationwide a few months ago.

i estimate theytheft ti be ariund 100,000 over 12 years.

i have documented some of the medical disabilities above.

ANY fear, terror, blood pressure rise, acicity, tiredness, viral infection, bacterial infection, can cause the athersckerosis to break, cause ischmic stroke and life threatening anaphylactic shock, at any time.

i now havevhousands of videos documenting this effect. icannot watch thrm.

RAYMOND should also be arrested for serious psychological harm to a child as 2020 amendment to thr Children's Act but that has not bwrn tskrn seriously either.

various other related crimes include CALDERWOOD manipulatinh y family and funding bodies, including telephoning RAYMOND and pleading with her to make a criminal false recommendation to get me Sectioned, as i was "obviously lying about her domestic violence".

CALDERWOOD then weaponised the failure of Essex Police to takr RAYMOND's crimes seriouly, falsely reporting to my fmily and funding bodies "he even made false reports to the police to try to gt his wife arrested!!!!"

(i have written email evidence of qt least one person claiming such a defamatory statement)

i have said enough. it is very distressing to go over this.
