i am absolutely aware that making a false report is a criminl offense. i absolutely fucking livid to discover from an SAR to the General

Medical Council that Hampshire Police claimed that a violent assault on 02nov24 was a FALSE REPORT. it means that the police ACCUSED ME OF CRIMINALLY GIVING FALSE INFORMATION which absolutely disgusts me.

i have MEDICAL EVIDENCE THAT I HAVE HAD CHRONIC ATHERSCLEROSIS UNDIAGNOSED as well as MASSIVE stroke damage (appx 8 large holes) and what is worse, the NHS acted CRIMINALLY by providing false information and failing to act to even perform basic diagnosis, placing my life in serious jeapordy when i had BRAIN HEMORRAGES ON A ROUTINE SYSTEMATIC BASIS AND BLOCKED CEREBRAL ARTERIES CAUSING BRAIN HYPOXIA SUFFICIENT TO MAKE MY EYES GO IN DIFFERENT DIRECTIONS

in light of CALDERWOOD and LEWIS placing me into deep shock multiple times, including on the 15th jan 2024 WITNESSED BY Shriya Sharma, including efforts by CALDERWOOD to wilfully manipulate my family, my funding bodies for my research, the cortisol triggered combined with the blood pressure rise was sufficient EACH AND EVERY TIME to cause calcium in my arteries to break, dumping toxins into my bloodstream, cause Anaphylactic shock AND SIMULTANEOUS ISCHEMIC STROKES.

i should be dead, from these life-threatening incidents that occured literally around 200 times in 18 months, and continue even now.

please start TAKING THIS SERIOUSLY, that CALDERWOOD and LEWIS and many others INCLUDING NHS PROFESSIONALS committed violent, violent assault that would normally KILL SOMEONE.

as it is i managed to barely stay alive, i don't know how, but i have bern documenting the effects of the strokes. at times unable to speak. loss of ability to do times tables. unable to sing in tune (i used to have perfect pitch). the list goes on and on.
