the police either did absolutely nothing, or catastrophically mis-investigated, causing me both shock and distress that resulted in ischemic strokes and life-threatening anaphylactic shock.

from 16 years domestic violence combined with hypoxia at birth that required a ventilator and oxygen for a month from age 2 to 6 weeks and caused serious brain damage, i have had chronic athersclerosis for at least six years.

the athersclerosis can break under any kind of duress or stress, such as a shock or fright, causing fragments of calcium, biotoxins and LDL Cholesterol to immediately get loose inside my arteries, causing an immediate lschemic stroke and usually anaphylactic shock due to the biotoxins.

if the blockage is big enough it can cause additional damage by BURSTING damaged cerebral arteries, at which point i can go into convulsions.

shock caused by both PC KING P7702 and also Inspector PARTRIDGE C7831 was recorded on video resulting in the above symptoms. they have both committed OAPA 46 and OAPA 18 offenses.

i reported an initial MALCOMS by CALDERWOOD, as well as an OAPA 18 Offense, neither of which was taken seriously and resulted in deep shock that caused strokes and anaphylaxis resulting in additional OAPA 46 and OAPA 18 Offenses by KING P7702 and PARTRIDGE C7831.

CALDERWOOD has been stalking me online, and has spoken with my friends, my family members, my former funding body, and also with police services, providing believable and plausible false information that is so sophisticated that it has taken TWENTY MONTHS for me to research the full extent of his criminal activity.

he put forward a false story, based on stalking me online, that i am delusional and violent, and require psychiatric treatment. he WILFULLY ignored video evidence that i posted online of being in life-threatening danger of death from Ischemic strokes.

the latest MALCOMs is that he claimed online that a true and accurate account of his fraudulent activity was false and malicious. it is too complex to go into in this initial report,

but as usual nothing that he writes online is actually truthful.

he also claimed publicly by implication that i would be arrested immediately on return to the United Kingdom (i was forced to flee the United Kingdom due to being tortured and at risk of death from Ischemic strokes which were occurring sometimes twice a day, in Nov 24, due to extreme violence and abuse by UHS A&E staff)

this claim by CALDERWOOD that i would be arrested turns out to be a FALSE CLAIM.

i spoke last week to Hertfordshire police, and established that there is no warrant out for my arrest.

however the very fact that CALDERWOOD made such a claim publicly online has caused deep distress sufficient to cause MULTIPLE Ischemic strokes.

on the face of it, CALDERWOOD's false claims appear to be purely MALCOMs. however in reality they are a continuation of his OAPA 46 and OAPA 18 offenses, due to the Ischemic strokes caused by the Cortisol breaking loose calcium fragments, LDL and biotoxins into my bloodstream.

VIDEO EVIDENCE OF THE STROKES AND ANAPHYLAXIS HAS BEEN RECORDED. where possible. one of the recent strokes actually caused me to be unable to move, so i was unable to hit "record" on my phone.

CALDERWOOD knew that i was in a domestic violence relationship: he and his wife put me up at their home for several days in 2023 when RAYMOND self-diagnosed as bi-polar then attempted a day later to claim it was myself, not her, that was bi-polar.

i have video evidence of hospital security staff being instructed to treat me as "a dangerous threat" when i am literally unable to walk and am forced to crawl along the floor
