I have informed you repeatedly of breathtaking fraud including DAVID CALDERWOOD claiming to be authorized by Company's House to make public malicious false claims and lying to a UK Minister, SAQIB BHATTI MP. I have not received even one response. I expect you to contact me, respect that I am severely at risk of death if distraught, to investigate and to contact the police, and provide them with evidence.
